Once your account has been established you will be issued a customer number and will be able to charge your transactions to it providing that you understand and agree to the following Terms and Conditions of sale:

1. Terms of sale are net 7 days from the invoice date for all fuel deliveries. Terms of sale on all other accounts are net 30 days from the invoice date.
2. All claims against invoices must be made within 30 days after receipt of good.
3. Accounts not paid by the due date are subject to an interest charge from the date of maturity at the rate of 1.5% per month.
4. NSF cheques will be subject to a \$ 25.00 service charge.
5. The supply of goods on credit may be discontinued if the authorized credit limit is reached or the account is past due.
6. Failure to comply with these Terms and Conditions may result in cancellation of credit privileges without notice. In the event of any default, Wasaya Airways LP may close the account and/or accelerate payment of the full balance.
7. Upon determination that the customer's creditworthiness has changed adversely or does not satisfy current credit standards, Wasaya Airways LP may close or lower the credit limited of the account.
8. The applicant agrees to bear all costs incurred in collecting any unpaid amounts including but not limited to collection suit fees, legal fees and court costs.
9. The applicant agrees it has the financial ability and willingness to pay for all invoices within established terms.
10. The information given in this Application and Agreement is warranted to be true and correct and given for the purpose of obtaining credit.
11. The applicant consents to the obtaining of credit and/or personal information as may be required in connection with the credit line hereby applied for or any renewal or extension thereof and to the disclosure of any trade information concerning the applicant to any credit reporting agency or to any person with who the applicant has or propose to have financial relations.
